# Information on the Title II US Forest Service Fiscal Year 2016 Application

Summary of Presentation:

- Marion County Extension and 4-H Service District was directed to bring grant applications to the board for discussion before submission.
- Marion County Extension would like to apply for Title II funds from the U.S. Forest Service.
  - o Requesting \$10,700 for the "Youth Enviro Squad".
  - Squad will work on environmental community activities and projects at the Willamette National Forest.
    - Range from ten to 24 middle and high school underserved youth living in the North Santiam Canyon.
  - Grant funds will not be used to pay the salary of any Extension staff.

#### **Board Discussion:**

- There are a limited amount of Title II funds available.
- Marion County Public Works Department is also applying for Title II funding for Salmon Falls parking improvements which is a health and safety priority over the Extension project application.
- Want Marion County Extension to plan and coordinate projects in the Santiam Canyon with Marion County.
  - o If Marion County Extension wants youth to perform community projects, a longer term discussion needs to take place to ensure these are "evidence based".
  - Marion County Youth Resources Action Team and the local Youth Development Council should be consulted.
- Marion County Extension will withdraw the project so that it does not conflict with Marion County's priorities.

# **Stormwater Fee Credit Program Implementation**

Summary of Presentation:

• In 2015, the board approved the stormwater fee for unincorporated East Salem.

- Fee is based upon a property's impervious surface.
- Board approved an automatic credit for commercial and multi-family properties.
  - Credit will expire in July 2017.
- County drafting a letter to property owners reminding them they are currently receiving a credit and must reapply to the county if they wish to continue receiving the credit.
  - o Applicants will be directed to the Public Works website to apply.

# Summary of Discussion:

- Letters to commercial customers should be very clear:
  - o Show the prior rate calculation compared to the new rate calculation.
  - o Ensure customers understand they are currently receiving a stormwater credit and must apply to the county if they wish to continue to receive the credit.
- Redraft letter and include estimates of how the credit will impact some of the larger businesses like ShopCo and Target.
- Public Works will create a process in case an application is denied and an applicant wants to appeal.
- Item will be brought back to a future Management Update meeting for the board to review.

## **Commissioner Janet Carlson:**

- Association of Oregon County (AOC) dues:
  - o Dues have not been raised since 2011.
  - Counties need to work together through AOC if we want to accomplish anything.
  - Very small (three percent) salary increase will result in higher dues to member counties.
    - AOC staff has not received raises for some time.
  - o Board of Directors makes the decision to increase dues, not the AOC executive committee.
  - o Commissioner Cameron and Marion County Chief administrative officer John Lattimer will meet with AOC executive director Mike McArthur to discuss the membership dues.

## Conflict of Interest Policy for non-profit entities.

- Working with Mid-Willamette Valley Behavioral Care Network (MWVBCN) on a conflict of interest policy.
- State of Oregon has just issued a new policy that includes "actual" and "perceived" conflicts.
  - State coming up with elaborate policies above and beyond what the law requires and making it more difficult for elected officials to serve and do their duties on these boards.
  - Linn County has written to the State of Oregon disagreeing with the new policy.
- Commissioner Cameron will ask the Mid-Willamette Jobs Council about the status of their conflict of interest policy since they are also a non-profit like MWVBCN.
