# Proposed Unmanned Aircraft System (UAS) Update

Summary of Presentation:

- Update on the options and uses of the budgeted purchase of unmanned aircraft for use in Public Works:
  - The particular multi-copter being looked at has a camera that is front facing and can rotate up and down for a very close look at different items as necessary;
  - It can be used for topographic mapping, 3D imagery, bridge inspections, road design, tower inspection, monitoring of unstable slopes, traffic corridor management, emergency management and flooding;
  - In order to purchase, must register with the Board of Aviation, undergo flight training or have an operator with a pilot's license, and apply for and obtain a Certificate of Waiver of Authorization;
  - The purchase will be from road funds and will cost between \$25,000 and \$50,000 with an annual support fee of \$1,500;
  - We could provide assistance to other counties, but our operator would be handling the multi-copter;
  - Would continue to work very closely with IT/GIS in regard to the software and should be able to utilize some of the data from the UAS for the GIS;
  - There are written policies regarding use of the UAS by other departments and there are Federal rules as to where and when the UAS can flown; and
  - Legal is looking at the policies currently and will develop a draft policy for the review of the Board.

### Review City of Salem Urban Growth Boundary Amendment for Third Bridge

Summary of Presentation:

- City of Salem has asked if the Board would hold a joint public hearing to consider adding property to the UGB in Polk County:
  - o There is about 30 acres involved and all are right-of-ways;
  - Being added due to the potential third bridge;
  - Some of the areas could have been added eventually anyway, as they do go in and out of city limits;
  - o City must bring in the property in order to go forth with the third bridge;
  - When Salem or Keizer add property to the UGB, their plans require that four jurisdictions agree to it---Salem, Keizer, Marion County and Polk County; and
  - o There is no Marion County land involved in the process.

- Salem is working on the third bridge and to receive final approval must get the Environmental Impact Statement approved by the Federal Transportation Agency:
  - Federal Transportation Agency won't approve EIS until all local items are completed;
  - A number of local studies and reports are being completed by Salem concurrently;
  - This is the only thing that involves Marion County;
  - o Also, only thing that involves all four jurisdictions; and
  - Once EIS approved Salem can move forward and look for money to build the bridge.
- Salem would prefer a joint hearing:
  - They want to get this done by the end of the year;
  - Marion County must provide feedback within a set time; and
  - There may be a great deal of public testimony involved and this way only one public hearing with the public testimony.
- At the hearing Salem would like to hear from the other jurisdictions if they concur with the expansion.
- Keizer and Salem want this bridge very badly.
- If Marion County voted against this then would enter into a standing mediation and appeal process.
- Salem will host and chair the meeting.
- Staff was directed to proceed with the meeting.

### Stormwater Fee Credit Program Implementation

Summary of Presentation:

- Continuation from an April 4, 2016 Management Update from which Board requested additional Information:
  - Provided outreach to Marion Water Quality Advisory Committee;
  - Presentation at the Salem Association of Realtors;
  - Invited Chemeketa Community College and Salem-Keizer School District to the Advisory Committee meetings; and
  - Updated the Marion County website to include the updated stormwater fee credit program information.
- Would like to "roll out" next week with a letter to the commercial customers that would be receiving the credits.
- This will take effect July 2017, but would like to make the applications available next week so the commercial customers can begin to apply immediately.
- Specific site information with fee credits requested at prior meeting:
  - Chemeketa Community College would receive a full credit and their fee would not change at all as they have several detention basins and bioswales;
  - Western Beverage would require a detention basin and they would receive a \$24.50 credit (approximate); and
  - Key Bank has no treatment at all and their fees increase by about 25%.
- A detention pond is a pond that water from the impervious surfaces on the site runs off into. It slows down and regulates the flow of water coming out which reduces the flooding risk during a large storm.
- A bioswale is similar to a rain garden where you would have water flowing into a vegetated ditch that has a slight slope so the water is held back at a specific rate. Similar to the detention pond you have a varying degree of reduction of flooding. Also has a soil mix underneath so the water can infiltrate into the soil. This reduces the total volume coming from the site.
- Staff directed to add in the letter "actions required by March 31<sup>st</sup> to retain partial or full credit driven by new Federal guidelines".
- Staff directed to revise the application to define what the account number is and provide the design standard information.
- Staff directed to update the FAQ's to highlight that this is mandated by Federal government.
