COMMUNICATIONS

Jolene Kelley, Public Information Coordinator, provided current updates:

- · Health Department dedication;
- Have Ms. Sparks schedule 2017 radio spots with department heads via GroupWise; and
- County website updated with emergency alerts notification.

INFORMATIONAL

North Marion and Salem-Keizer Transfer Stations proposed yard debris rate increase - Brian May

Summary of Presentation:

- · Haulers rates increased;
- Have not yet increased yard debris or food waste processing charges to the public;
- Will raise tip fee from \$47 per ton to \$59.49 per ton; and
- Would like to take to board session this week and make it effective December 1, 2016.

Board Discussion:

- This is a public fee increase;
- Minimum fee of \$15 is about 400lbs;
- Anticipated this fee increase;
- Corvallis is charging the county more, so the increase is passed through to the customer at the North Marion and Salem-Keizer transfer stations:
 - Contract is up for renegotiation.
- Mr. May will let the board know when the last time the fee was increased at his presentation on Wednesday.

Public Works debrief and discussion - Alan Haley

Summary of Presentation:

- Emergency management:
 - New grant study for interoperability of all agencies in an emergency situation;
 - o Pushing radio manufacturers to make radios with bands that talk to each other; and
 - Voice and data transfer.
- Infectious waste contracts:
 - Two out of county medical waste customers;
 - o Guarantee no fetal tissue waste; and

- Nothing different than what the county has been doing for years.
- Appointment of new Building Inspector Mr. Troy Wheeler:
 - Currently Senior Plans Examiner;
 - Only fully certified person in the office who qualifies as a building official;
 - o Not a supervisory role; and
 - o Required by the state.
- Appointment of Mr. Joe Fennimore to Planning Director and Zoning Administrator:
 - Currently doing most of the work; and
 - Non-supervisory role.
