John Lattimer called the meeting to order at 9:30 am.

#### INFORMATIONAL:

#### Review the 2016-17 Comprehensive Annual Financial Report (CAFR)

- Cynthia Granatir & Jeff White

#### Summary of presentation:

- Once the board approves the CAFR, it will be added to the website, which is Finance's main form of distribution of financial statements;
- Received an unmodified audit opinion on the financial statements;
- New note disclosure in accordance with governmental accounting standards regarding tax abatements:
  - The purpose is for governments to disclose the impact on their revenues of tax abatement programs; and
  - Only property taxes are subject to the new requirement.
- The Finance Department, along with the Assessor's Office, obtained the information needed to estimate the impact of tax abatements:
  - All tax abatements that impacted Marion County were issued by other government agencies; and
  - The disclosures are fairly minor.
- All property tax accounts that have an exemption are in a spread sheet on Finance's website;
- For fiscal year 17-18, Finance will be implementing new reporting standards for post-employment benefits other than pensions:
  - This will impact the countywide bottom line;
  - The only benefit that Marion County has that falls under the standard is the Implicit Rate Subsidy:

- Statutorily required to allow retirees to participate in the health insurance plans as the same rates as county employees.
- The deficiencies noted were minor:
  - The items do not meet the threshold of reporting.
- This will be added to Board Session for approval next Wednesday.

# Discuss selling Tax Foreclosed Property located at 7681 Rambler Drive NE, Salem back to the Prior Owner

# Summary of presentation:

- Parcel was taken into foreclosure a few years ago;
- Attempt to contact previous owner, which was a bank, with no response;
- Put the property on the auction list;
- The neighbor to the property was interested in buying property;
- Received a letter from a previous owner to purchase the property back;
- Pulled off of the auction list to bring to board's attention;
- In the past, Finance has honored the request of previous owners to buy the property back;
- The prior owner was foreclosed on, is stating that the bank foreclosed on his property and lost track of the second lot, and Marion County took it over:
  He has been negotiating with the bank to get the property back.
- Marion County only recovers pass due property taxes and recovered costs.

# Board discussion:

- The commissioners are in agreement to sell the property back to the previous owner; and
- The commissioners would like to know what code issues there were with the previous owner.

# Review Applications for the Vacant Seat on the Oregon Garden Foundation that Marion County Appoints

# Summary of presentation:

- In the bylaws, there are five seats on the foundation board:
  - Two seats are under the authority of Silverton; and
  - Three seats are under the authority of Marion County.
- Gloria Roy is the most knowledgeable about the Oregon Garden properties:
  - Would bring a broader representation to the foundation; and
    - Interest in agriculture and farming is well suited.
- On Board Session for next week;
- Bylaw revisions will be before the board at the end of the month:
  - The foundation board is proposing to grow from five to seven seats;
  - The two added seats would be appointed by the Oregon Garden Foundation; and
  - The Oregon Garden Foundation currently does not have appointment authority.
- Ms. Goettsch is recommending Ms. Roy for the position.

#### **Board discussion:**

- Marion County would have the majority of the members on the board;
- Once all three seats are filled, there is a need to advocate diversifying membership; and
- The commissioners agree with appointing Gloria Roy.

### **Discuss Personal Property Taxes for Agribusinesses**

# Summary of presentation:

- On the first of the year, the Assessor's Office mailed business personal property letters to property owners:
  - o 128 agricultural businesses; and
  - o 6,455 went out to existing personal property accounts.
- Still hasn't received a single phone call regarding the letters;
- Included is a copy of a letter of explanation;
- Interested in treating all businesses the same;
- Has not received filings of personal property returns to agricultural businesses;
- There are various exemptions on property taxes:
  - Machinery and equipment are taxable, but exempt under certain categories; and
  - Any personal property associated with planting or harvest is exempt.
- Very complicated process;
- Trucks for planting and harvesting are exempt;
- Received a public records request from Kevin Mannix's Office for a list of the agricultural properties that the letters were mailed out;
- There is a personal property tax liability of \$16,000;
- This is an accounting problem for property owners;
- It is an accounting and administrative problem for the Assessor's Office;
- Generates revenue for the county, but it is more costly in employee hours to process the paperwork;
- Cannot foreclose on personal property;
- Looking to create equity across the board; and
- The program is based on the honesty of the business owner.

  - o Residents from Wilsonville are trying to get it stopped; and
  - Rep. Lewis would like a letter of support from the commissioners.
- Cap and Trade bill:
  - Senator Courtney didn't consider landfills or the waste-to-energy facility:
    - Willing to listen to the amendments proposed.
  - They do not have the votes to pass the bill in the House or Senate at this time;
  - The amendments exempts Covanta; and
  - Trying to get the bill amended before it comes out.
- Toured GEM Equipment;
- Attended Regional Solutions;
- Touring Detroit Dam on Saturday, January 13th; and
- Attended Marion County Public Safety Coordinating Council.
