## Summary of presentation:

- The previous owners are both deceased;
- A lawyer came forward claiming successor;
- Narrow strip of land;
- The intention is to sell property to Habitat for Humanity;
- City of Woodburn Planning Department stated it is a difficult piece of property to see due to set backs:
  - o Gravel road on one side of property.
- Recommendation from the Finance Department is to sell the property back to the estate.

## Summary of presentation:

- State Office of Developmental Disability Services under Department of Human Services had communicated that they were needing to find \$12 million in general funds out of the program;
- Looking at potential strategies of capping children's services or potentially implementing income contingencies;
- DHS was able to pick some management strategies and find the \$12 million in general fund:
  - \$1.3 million in contract reductions;
  - With the implementation of the Oregon Needs Assessment tool, it will reduce the cost per case; and

- Shifting around funding to receive a higher match from the federal government.
- DHS is looking at a budget shortfall for the next biennium;
- Have seen a significant rise in eligibility;
- Contract reductions with the state has affected the shortfall; and
- The state hasn't been receiving as much money from the federal government.
