Measure 24-106: Aurora RFPD - Local Option Tax for General Operations and Capital Projects

Local Option Tax For General Operations and Capital Projects

Question:

Shall the Aurora RFPD impose a local option tax of \$.68 per \$1,000 for five years beginning 2003? This measure may cause property taxes to increase more than three percent.

Summary:

This measure may be passed only at an election with at least a 50 percent voter turnout. The Fire District will use the tax revenue from this measure for capital projects and general operations. The part for general operations would increase staffing from one person to three personnel. The part for capital projects would include the replacement of a 1974 Fire Engine, the replacement of a 1975 Fire Tanker, replace outdated airpacks and airtanks for firefighting, replace outdated defibrillators for medical calls, purchase a staff vehicle, and purchase property for facility improvements. The proposed rate would raise approximately \$275,885 in 2003-2004, \$284,162 in 2004-2005, \$292,686 in 2005-2006, \$301,467 in 2006-2007, \$310,511 in 2007-2008, for a total of \$1,464,711.

Explanatory Statement:

The Aurora Rural Fire Protection District was established in 1948. It covers 64 square miles of property and includes the Cities of Aurora and Donald. It was staffed exclusively by volunteers until 1995. At that time one paid employee was hired to do all of the maintenance, training, record keeping, and respond on calls as an Officer. We now have 47 Volunteer firefighters, who responded to 750 calls of service in 2002, and still only one full time employee. The District needs to hire two more full time employees to provide a safe level of operations.

For the safety of the District patrons and employees, we need to replace some outdated equipment and apparatus.

This includes replacing a 1974 Fire Engine, a 1975 Fire Tanker, outdated defibrillators and air packs.

Looking to the future, the District needs to purchase land for facility expansion.

A local option tax of \$.68 per \$1,000 of valuation would fund these necessary equipment replacements and staff increases.

Measure 24-109: City of Turner - Recall of Jim Thompson, Mayor of Turner

PETITIONERS' STATEMENT: (Exactly as stated on Recall Petition)

These councilors violated TRC Section 2.06.10 by taking this action during "other business".

STATEMENT OF JUSTIFICATION: (Exactly as submitted by Jim Thompson)

I voted to release Charles Spies as City Administrator for a number or reasons including a serious breakdown in credibility. Retaliation by recall is the proposed remedy. The Oregon Constitution allows voters to recall elected officials but no reasons are required. The only opportunity for rebuttal is with their constituents. A review of ALL of the facts should be made before voting.

You're told the Council failed to consider just cause when it took its action. The Turner City Charter says, "A majority of the council shall appoint and may remove the administrator." It also says "The administrator shall be a appointed for a definite or an indefinite term and may be removed by the council at its pleasure." The Employment Agreement the City had with Mr. Spies said "Nothing in this agreement shall prevent, limit, or otherwise interfere with the right of the City Council to terminate the services of Mr. Spies at any time." "The City retains the right to terminate the services of Mr. Spies with or without cause."

The council's action was consistent but those who disagree want to escalate the confrontation with recall proceedings. It appears personality rather than performance is their issue.

Measure 24-110: City of Turner - Recall of Jeff Long, Council Member

PETITIONERS' STATEMENT: (Exactly as stated on Recall Petition)

Jeff Long and other Council members fired the City Manager without cause on June 26th.

Very recently the council gave Mr. Spies a good evaluation, a 3-year contract, a raise, and this following good ratings over his tenure.

These councilors violated TRC Section 2.06.10 by taking this action during "other business".

"Action shall not be taken until a subsequent meeting unless deemed urgent". The reason this is in our code is to give citizens notice, allowing them a chance to respond. Action was not deemed urgent by the council and was acted upon anyway. Citizens were not allowed to respond nor was Mr. Spies given a chance to defend himself against unsubstantiated claims made by councilors.

STATEMENT OF JUSTIFICATION: (Exactly as submitted by Jeff Long)

In my opinion Mr. Spies misrepresented the interests of the community. Some of the specific issues are:

- 1) Told former property owner, without Council authorization, the City would take condemnation action if the owner refused to grant the City rights-of-way. This led to the owner selling to a developer.
- 2) Approved issues related to the Calpine application contrary to the City's land use rules, without seeking approval of the Council or the Planning Commission.
- 3) Telling the Council on numerous occasions that if it authorized Staff to pursue an enterprise zone on Calpine's behalf the Council could withdraw at any time. When the council consided withdrawal Spies said it was legally too late to do so.
- 4) Allowed total clear-cutting in the Well's subdivision, after telling Council and Planning Commission the only trees to be cut were for street location.
- 5) His continual attempt to control the council, planning commission and committees, is direct violation of Turner's City Charter.

When elected to the Council, voters didn't state I'd have to vote the way certain people demanded, but it now appears that's why I'm on the recall ballot.
