 See the Campaign Finance Manual for the procedural and legal requirements of establishing and maintaining a candidate committee.

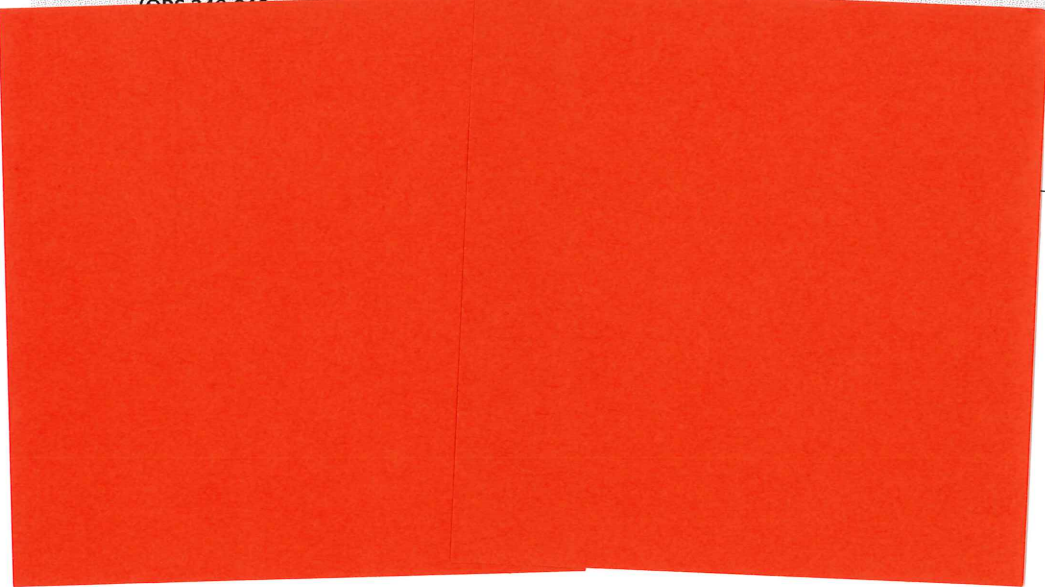
