QA Review: Patty shared that the onsite review ended early, and she was able to access the data on Monday. The exit interview is scheduled for April 18th. Patty has complied a

list of what she expects to see on the report and will share the final results with the committee when they are available.

Other Business:

Voc Rehab Concerns: Committee discussed concerns regarding the time it takes to get set up for meetings with Voc Rehab and miscommunication about who should be present for these meetings. We will continue the discussion at May's meeting.

Service Equity Assessment: Corissa shared that a Department wide Service Equity Assessment was conducted by a 3rd party last year. The assessment consisted of Staff Surveys, Management Interviews, Staff Focus Groups, Community Partner Surveys & Individuals in Service Surveys. Corissa highlighted a few Successes from the survey results.

Flex Funds & Mini Grants: New applications will be sent out to the committees to review with the updated scoring sheet.

IDD Conference Planning: Would like to start planning a Big Event for March of next year. Will get a team together to start planning if you are interested let Corissa know.
