### **Call to order & Introductions –**

### **Approval of Meeting Minutes: (handout)**

### **Discussion: MCADPC conference –**

### **Update: HAB: Debra**

House Bill 2257 -Declares legislative intent to consider substance use disorder as chronic illness. Debra will provide link to Tanya to send to committee.  
How can MCADPC committee support this bill?

United Way raising funds for mobile shower/bathroom units for homeless. Presently, they are collecting socks and under garments to have on site at mobile units.

### **Update: Public Safety Committee – Cari**

Many discussions around legislative house bills in meetings:  
Senate Bill #7 regarding lowering blood alcohol limit to .05 Marion County does not file DUI's under .08.  
Opiate epidemic – 3 Oregonians die a week of an overdose. In 2016, 500 pregnancies in Oregon were complicated by Opiate use. Oregon ranks last in treating substance use disorders. Oregon does not use Prescription Drug Monitoring Program (PDMP) before prescribing.

Covered Bridge Café working with Stayton pool and clothing shop starting next month, to offer shower and clean clothes to those in need.

Cari would like a member of MCADPC to present, and give information, at a Public Safety Committee about the conference.
