**Discussion:** COVID-19 Updates:

Marion County providing services mainly via Telehealth but some face to face for high risk groups.

Her Place still operating; working with Bridgeway for testing and transition.

Continuing to experience cases at higher rate; some numbers due to more testing.

Locate current data at Marion County COVID 19 dashboard.

Willamette Valley Treatment Center has been hiring staff and has filled 3 of 4 counselor positions and just hired an RN as well. Individual counseling held over the phone and limiting contact with clients as much as possible.

**Update:** Public Assistance Grant, Marion County:

Jeff working with FEMA on grant. 15 to 16 people have stayed at hotel since beginning of July. There was a lawsuit filed which is ongoing/pending.  
Marion County staff acting as hotel manager.  
There is a public health nurse on site and wraparound services available.  
Marion County deputies take shifts and monitor security.

Jeff was able to distribute 824 cartons of Narcan as of the end of June, and still has some on hand. He has been picking up and replacing expired product.

Discussion around whether there are specific protocols with Meth treatment.  
Deb will do some research with providers regarding this.

Sub committee working on transcript.  
Will coordinate with NOWS.

**Update:** HAB - Deb Giard  
Ryan Matthews was appointed as Health & Human Services Administrator. He has served as Interim Administrator since January 2020 and has served Marion County in various roles over the past 16 years. His appointment was effective August 1, 2020.

**Update:** Public Safety Committee  
No update – committee has not been meeting.
