EPA’s SmartWay Transportation Program

Are fuel prices putting a strain on your business? Participating in the EPA’s SmartWay Program can help your company save fuel, money, and the environment. In 2004, the EPA launched SmartWay– an innovative brand that represents environmentally cleaner, more fuel efficient transportation options.

In its simplest form, the SmartWay brand identifies products and services that reduce transportation-related emissions. However, the impact of the brand is much greater as the SmartWay brand signifies a partnership among government, business and consumers to protect our environment, reduce fuel consumption, and improve our air quality for future generations.

All of EPA SmartWay transportation programs result in significant,

measurable air quality and/or greenhouse gas improvements while maintaining or improving current levels of other emissions and/or pollutants.

The SmartWay Program has a number of services available. The SmartWay Vehicles Program helps consumers identify the cleanest, most fuel-efficient vehicles available. The SmartWay Transport Program is a freight transportation partnership that saves money and reduces fuel consumption. The SmartWay Financing Center assists technology and truck financing and the SmartWay Tractors and Trailers Program assists businesses in learning the advantages of choosing an EPA Certified fleet. Marion County Transfer Station Rate Increase



Marion County Transfer Station garbage rates will increase October 1, 2008.

The Marion County Board of Commissioners recently approved an increase in the minimum charge for garbage customers at the Marion County Recycling and Transfer Stations. The rate will go from a \$9 to \$13 minimum on October 1, 2008 and then from \$13 to \$15 on October 1, 2009. The minimum charge for yard debris and wood waste

did not change, and will remain \$9 per transaction. These changes do not impact the Brown's Island Demolition Landfill. As always, recycling services at the Marion County transfer stations remain free. The rates at the transfer stations have not increased since 1992 while other out-of-county disposal sites have risen substan-

tially over the years. Marion County's lower minimum charge has created an incentive for out-of-county waste to be disposed of at the Marion County transfer stations. Increasing the minimum charge will likely reduce the number of out-of-county minimum charge customers that visit the transfer stations.

Common Recycling Myths

Myth 1: Paper Coffee Cups are Recyclable

The truth is, paper coffee cups can not be recycled. The plastic interior liner, which keeps the liquid inside of the cup, poses a problem when the paper cup is pulped down to be recycled. The solution: Carry a reusable mug instead!

Myth 2: Plastic Bags can be Recycled in our Mixed Recycling Bin

Plastic bags are highly recyclable. However, plastic bags are a haz-

ard to the machinery that sorts recyclables at the 'materials recovery facility.' The solution: Recycle your plastic bags at local grocery stores or the Marion County transfer stations. Better yet, carry a reusable bag!

Myth 3: All Paper Clips, Staples & Spiral Binding Must be Removed from Paper Before Recycling

Removing paper clips, staples, and spiral binding from paper before recycling it is not necessary! These materials

will naturally be removed during the recycling process.

Myth 4: Fluorescent and Colored Paper is not Recyclable

All paper, regardless of color, is recyclable. Paper items that can not be recycled include carbon forms, paper cups, paper plates, paper towels, and napkins.
