WHEREAS, Marion County fully participated in the FEMA-prescribed mitigation planning process to prepare this Multi-Jurisdictional Natural Hazards Mitigation Plan; and




WHEREAS, the cities of Aurora, Keizer, Silverton and Woodburn developed updates to their respective city addenda, and


RECOMMENDATION: It is the recommendation of Marion County Public Works - Emergency Management staff that the Board of Commissioners accept the plan by resolution.
